Attorney Katelyn Knight presented on what the HRC is charged with... (Ord. No. 1698 N.C.(2d), § 1, 5-27-2014) The primary purpose of the Vallejo human relations commission is to promote the equal treatment of all individuals; to prohibit discrimination in the city of Vallejo based on race, color, national origin, religion, sex, disability, age, genetic information, marital status, sexual or gender orientation and identity, medical condition, political activities, military or veteran status, or status as a victim of domestic violence; to be a community educator, conciliator and mediator to create a climate favorable to good human relations among people in the community and to promote just and positive interactions between and among people and groups in the community.
