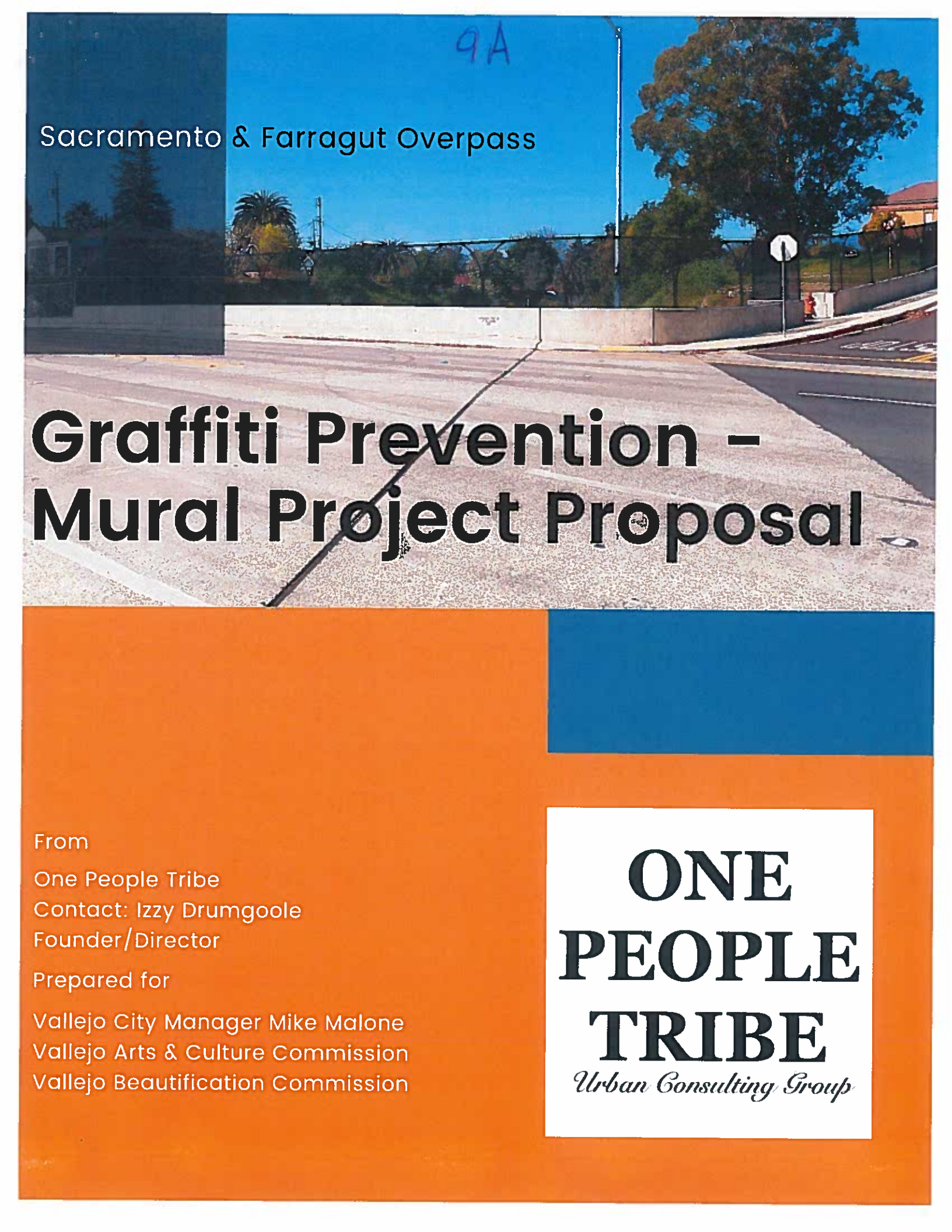

About Us

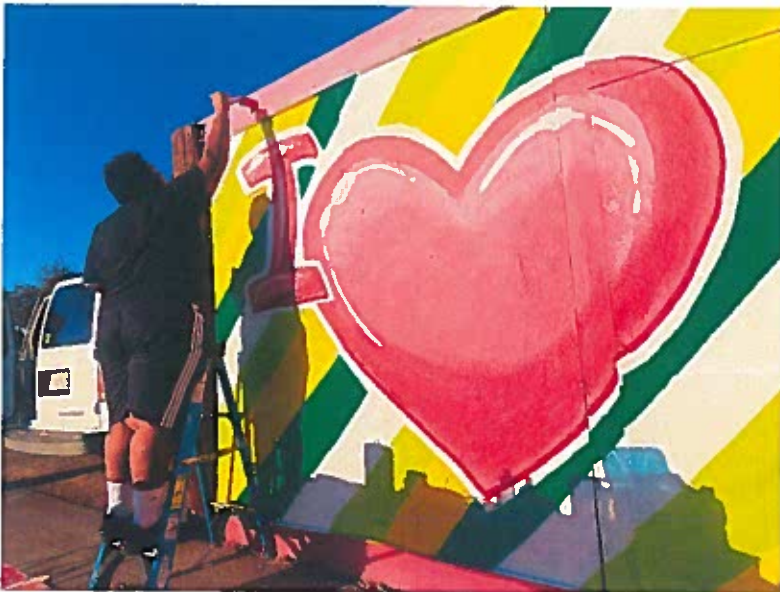

Project Summary

Mind Garden Mural Arts Training Program was developed in 2021 by One People Tribe (funded by CA Arts Council), to serve as a mural apprenticeship to teach Vallejo's transitional aged youth professional mural making skills. It is with this program that we propose a new Graffiti Abatement & Mural Training Partnership with the City of Vallejo

Sacramento & Farrgut Overpass has been identified by the city as a newly developed site at high risk of unauthorized graffiti and tagging. This project site, located on a main thoroughfare, would serve as an ideal location for an initial public art beautification pilot project and launch point for this partnership.

Our team of Professional Muralists, teachers and project managers will work as a team with parents and youth as we lead them step-by-step through the mural making process: design development, design iterations, presenting designs to client for approval, site preparation, installation processes and procedures, mural preservation/graffiti proofing and planning of a community mural unveiling. Pilot project length is projected to last approximately 4-6 months.

What One People Tribe is proposing is to work in tandem with the city of Vallejo to activate youth, parents and community members in creative civic engagement that encompasses public art education, skill development, community service, graffiti prevention and abatement.



Narrative

The Sacramento & Farragut Street newly redeveloped overpass intersection is a testament to the city's commitment to progress and innovation. With its modern design and cutting-edge infrastructure, it stands as a beacon of hope for the future.

To further enhance the beauty and vibrancy of this significantly upgraded site, we propose the creation of a new mural that captures the essence of the community and celebrates its diversity and resilience.

The mural will be a collaboration between One People Tribe artists, youth, parents and community members who will come together to create a stunning work of art that reflects the unique character and spirit of the neighborhood.

The theme of the mural will be "Unity in Diversity," and it will blend the many different cultures and traditions that make the community so special. The mural will feature a colorful array of imagery, symbols and abstract elements that will represent the various ethnic groups, nationalities, traditions, musical influences and environmental aesthetics that make Vallejo what it is.

From vibrant patterns and motifs to intricate designs, the mural will be a true masterpiece of artistic expression and cultural exchange. It will serve as a reminder that, no matter our differences, we are all united by our shared humanity and the desire to create a better world for ourselves and our children.

The mural will be painted on the overpass walls, providing a bold and striking visual statement that will be visible to all who pass through the intersection on their way to and from Downtown Vallejo. It will be a source of inspiration and pride for the entire community, showcasing the creativity and talent of its youth and residents while celebrating its rich cultural heritage.

In conclusion, this mural pilot partnership is a bold and exciting vision for the future of Vallejo, one that the community can see the results of in realtime. This is an opportunity to support our youth and families, honor our rich history of unique diversity and strengthen one neighborhood at a time, all while creating stunning works of art. We can assure you that with each new mural site, each street, block, neighborhood and the whole city will become a more welcoming and engaging environment for residents and visitors alike.

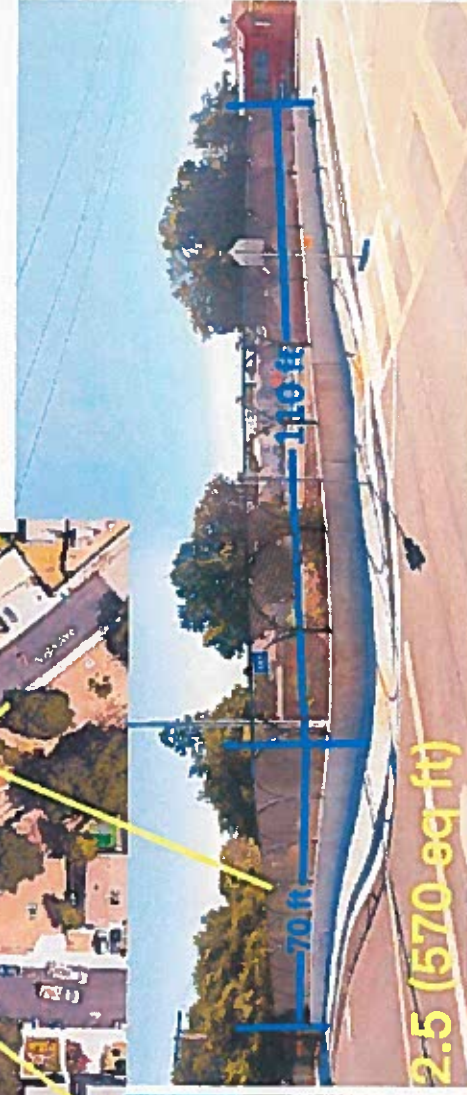
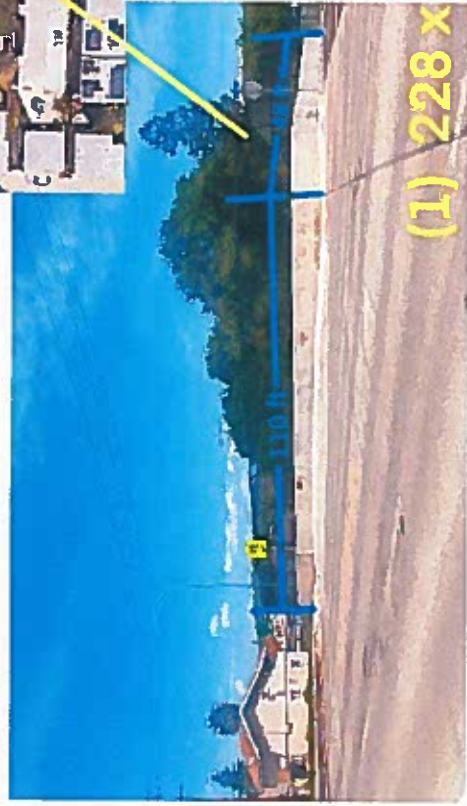

Project Activities



The project will be divided into two phases. The first phase will involve community outreach and engagement, while the second phase will focus on the actual development of the mural. During the first phase, we will engage with local youth and parents through a series of educational skill building sessions where we will discuss the collaborative project and significance of the mural, and encourage participants to share their ideas and vision for the design elements to be included in the mural. The participants will then present their design concepts to the appropriate City of Vallejo Staff/Commissioners/Manager for approval.

In the second phase of the project, One People Tribe's team of professional artists will train and supervise participants throughout the installation of the mural. Youth and parents will have ample opportunities to participate in the actual painting of the mural, so that they can truly take ownership of the project and feel proud of their contribution to the community.

Project Goals:

The proposed project has several goals, including:

To engage local youth and parents in a collaborative effort to design and install the new Sacramento & Farragut overpass mural.

To preserve the cultural significance of Vallejo, while creating a new, modern design that reflects the ever changing community.

To provide opportunities for youth and parents to develop their artistic skills and gain experience in creative community civic engagement and leadership.

To create a renewed sense of pride and identity in the community by beautifying a prominent public space and showcasing the talents of local youth and parents.



Proposed Timeline



Sample Timeline:

The proposed project will take approximately 4-6 months to complete. The timeline for the project is as follows:

Phase 1: Community Outreach and Engagement (2-3 months)

Hold training sessions to engage with local youth and parents

Discuss the history and significance of the partnership and mural project

Encourage participants to share their ideas and vision for the mural

Phase 2: Design Development and Installation (3-4 months)

Finalize the design of the mural with the input of local youth and parents and present to City of Vallejo for approval

Work with One People Tribe's professional artists to train and supervise the installation of the mural

Provide opportunities for youth and parents to participate in the actual painting of the mural

Work with participants and the city to plan, schedule and facilitate a mural unveiling event and community celebration

Expected Outcomes

Exposure to public art and mural making experiences can have a variety of positive outcomes for communities, such as:

Increased sense of community pride and identity: Public art can help communities feel a stronger sense of identity and pride in their surroundings. This can lead to greater community involvement and a sense of ownership over shared spaces.

Improved mental health and well-being: Studies have shown that exposure to art can have a positive impact on mental health, reducing stress, anxiety, and depression. Public art can also help create a more pleasant and inviting atmosphere in public spaces, which can improve overall well-being.
