- A. City Council Liaison Report – Councilmember Arriola reported she attended the opening of the Hispanic Heritage Month at the Vallejo Naval & Historical Museum.
- B. Commission Liaison Report – No report, comments will be made throughout the agenda.

5. **PRESENTATIONS**

- A. JeanCherie, Wendy the Welder Project, gave a brief biography on her career and presented a video on how Wendy the Welder Project came into being, including the stories of Rosie the Riveter, who assembled ships and ammunition for the Second World War, who included more than 9000 women working on Mare Island building ships for the Navy. Because there is no monument to honor the service of women who worked on Mare Island, she wanted to create a sculpture of Wendy the Welder to tell the proud maritime history of Mare Island that includes women, who have been ignored. She is seeking support to make Wendy the Welder a reality. She has a specific location in mind on Mare Island and has talked with the Mare Island Co. She needs funds to build sculpture in the amount of approximately \$250,000. She responded to questions from the Commissioners. Request to put on the Future's List for next month's meeting. Vice Chair Cook volunteered to work with JeanCherie to place an article about Wendy the Welder project in the Vallejo Weekly.
